Brennan needed to leave us unexpectedly about one month into her position with TLT but, true to form, the Tuckernuck community stepped up to ensure the plover and oyster catcher nests and young continued to be supervised. Board members Dr. Dick Veit and Ella Potenza recruited, scheduled, and trained a succession

of monitors to ensure a continued TLT presence on Tuckernuck's beaches. Huge thanks go out to Tucker Taylor, Skyler Kardell, Samantha Monier and Danielle Fibikar for answering our call for help!

Notes from the Field

In total, we had fourteen fledged Piping Plovers—eight chicks from North Pond and six from Whale Point. There were also five fledged Oyster Catcher chicks, four of which hung around East Pond, with one near the dock in the Lagoon... This season also brought a remarkable number of terns. We saw plenty of Roseate, Common, some Least, Black, and a few Foster's Terns towards the end of the season.

FIELD STATION UPDATE

TLT is one step closer to achieving our goal of a nearly carbon-neutral field station. Knowing that the federal solar credit would no longer be available after this year, we made the decision to move ahead with the solar portion of the project even though we had not yet raised the full funding needed for the combined well and solar installation.

In late August, as we were finalizing arrangements for Conrad Geyser and his team from Cotuit Solar to install the system, we learned that the the grant application for the Nantucket Offshore Wind Community Fund at the Community Foundation for Nantucket had officially opened. We applied for a \$10,000 grant, which would free up more of the funds already raised to support the well portion of the project. The new solar panels and battery system were installed in early September, a major milestone in improving the station's resilience and reducing its carbon footprint.

There is still work ahead, including the purchase and installation of a new, energy-efficient electric refrigerator next spring, but we're excited to have made significant progress toward our goal. We're grateful to everyone who has supported this effort. Between the grant funding, the direct pay solar tax credit, and generous donations from our supporters, the solar

portion of the project will be fully funded.
There is still a little way to go to fund the well and new water pump, but with your help, we expect the project to be complete by summertime.
